

# 2010 Oklahoma Judo Association Annual Business Meeting

## **Distribute 2011 Club Registration Forms**

USA Judo 2011 Club Registration Forms were distributed to representatives of the clubs present before the meeting was called to order.

## **Call to Order**

The meeting was called to order at 1:13pm December 18, 2010 by President Steve Kenton at the Sooner Judo Club in Cleveland County, Oklahoma, per previously issued meeting announcement.

## **Quorum**

Represented by the following clubs with the number of members/votes for each: Anshin Arashi, 2; Kyoudai, 6; Matrix Grappling, 39, OKCDT, 56; Sooner, 41; Triton, 8; Tulsa, 76; UOK, 3; USA Stars, 74; Yoons, 3.

## **Minutes of the Previous Meeting**

The minutes of the previous meeting were read. Motion for approval of the minutes by Martin Bregman was seconded by Leah Kenton-McGaha. The minutes were approved as read.

## **Old Business and Committee Reports**

### **Promotion Board report - Martin Bregman**

As of the date of the meeting, this year the Promotion Board has approved 72 junior promotions and 77 senior promotions, including two Shodans. The Promotion Board approved minor changes to the OJA Promotion Exam. The Board also approved abbreviated examination procedures for elite players who place highly in national and international competitions.

Martin also discussed the rebates given to players who compete at national events. Motion to approve the Promotion Board report by Bill Patten, seconded by Leah Kenton-McGaha, was approved.

### **Financial report - Jim White**

The 2010 financial report was given by Jim White, Secretary/Treasurer, who discussed changes from the previous year. The OJA should post a small profit after the rebates to national competitors are distributed before the end

of the year. Motion for approval by Martin Bregman, seconded by Danny Martin, passed.

### **Membership report – Steve Kenton**

Current USA Judo/OJA membership stands at 338 at the end of 2010, up from 285 in 2009.

### **New Business**

#### **Election of Officers**

Steve Kenton and Bill Patten were nominated for the office of President. Bill Patten was elected by a majority of the votes cast.

Mike Darter and Andy Kriegel were nominated for the office of Vice-President. Mike Darter was elected by a majority of the votes cast.

Rebekah Taylor was the only nomination for Secretary/Treasurer and was elected by acclamation.

#### **Adjournment**

Motion to adjourn by Clint Dake, seconded by Andy Kriegel, was passed.

#### **Technical Clinics**

The meeting was followed by a technical clinic on setting up and managing pools and a second technical clinic on running the electronic scoreboard.
